ACHIEVEMENTS OF THE CHAMBER FROM DURING THE YEAR 2024-25

1. 13-07.2024 :

Letter to Shri R. K. Sudhanshu, IAS, Chairman, Uttarakhand Pollution Control Board about to extend time for shifting of Boilers of Industries from Pet Coke / Furnace Oil to Bio Fuels.

ACHIEVEMENT IN THE ABOVE MATTER

- i. After the Sl. No. xi of "Approved Fuel" an extra following fuel has been added;
 - xii. Low Sulphur Furnace Oil having sulphur content less than 1.8% by weight.
- ii. For the industries using Pet Coke in the process, the time limit for switching over to Approved Fuels is extended from 31.03.2024 to 31.12.2024.
- iii. Due to the continuos follow-up by the Chamber, the Uttarakhand Pollution Control Board has granted an exemption to industries for converting from petcoke to biofule in boilers, with the deadline extended up to December, 2025.
- 2. For the development of the Chamber and MSME Industries, an MoU has signed between Small Industries Development Bank of India (SIDBI) and Kumaun Garhwal Chamber of Commerce and Industry (KGCCI) on 20th Dec., 2024 at Hotel Rudra Continental, Rudrapur
- 3. Due to the continuous efforts of the Chamber, the UPCL has approved the construction of 3 No. 33/11 KV Power Sub-Stations in SIDCUL Pantnagar. The UPCL is talking with SIDCUL to provide land for their establishment.
- 4. On the demad of KGCCI, the State Government has allowed tourism to be registered under the old Tourism Policy. With this, under-construction units will also be able to avail incentive benefits prior to the implementation of the New Policy.

- 5. Due to the rational facts put forward by the Chamber before the Government in the interest of industries, the tax proposed by the Uttarakhand Government on Ground-Water used in industries has been withdrawn.
- 6. Through the efforts of the Chamber, the environmental compensation imposed in large amount on 54 industrial units has been reduced by more than 50%. The Chamber is also actively opposing this, fow which it has requested the computation sheet from Uttarakhand Pollution Control Board.
- 7. For the Development of the Chamber, an MoU has signed between Electronic Service and Training Centre (ESTC), Ministry of MSME, Govt. of India, Kaniya, Ramnagar and Kumaun Garhwal Chamber of Commerce and Industry (KGCCI).
- **8.** The Chamber facilitated the resolution of issues related to permits, transportation, and licensing of methanol used in industries.
- 9. The Chamber delegation met with Shri Udya Raj Singh, IAS, the then District Magistrate of Udham Singh Nagar and successfully resolved the issues of unnecessary inspection and harassment faced by industries involved in wheat procurement.
